RATING MINIMUM REQUIREMENTS

All minimum requirements must be met for a program to qualify for a rating

1. Foundation of Quality

The program is fully licensed by the Utah Dept. of Health Child Care Licensing Program, which enforces foundational health and safety standards in child care facilities.



- License in good standing

2. Building Quality

The program is implementing practices that can lead to high quality including participating in observations and may also include additional technical assistance, professional development and coaching for program staff.



- License in good standing
- At least 10 points on the Observation component
- Minimum 48 total points

3. High Quality

The program creates an environment that supports good outcomes for children. Observed interactions are educational and built on positive relationships. The program continues to support high-quality care through ongoing professional development of staff.



- License in good standing
- At least 21 points on the Observation component
- No civil money penalties assessed
- ERS Score of 3.67 or higher in each observation
- Minimum 88 total points
- Scored at least a 4 for Language and Books subscale for each ERS observation
- Licensing Compliance: At least 5 points
- Scored at least a 4 for Interactions subscale for each ERS observation
- Education of Primary Caregiver: At least 5 points

4. High Quality Plus

The program is shown to continually go beyond the required standards for high quality.



- License in good standing
- ERS Score of 3.67 or higher in each observation
- No civil money penalties assessed
- Scored at least a 4 for Language and Books subscale for each ERS observation
- Minimum 128 total points
- Scored at least a 4 for Interactions subscale for each ERS observation
- Licensing Compliance: At least 10 points
- Education of Primary Caregiver: At least 10 points
- At least 25 points on the Observation component
