Utah's School Readiness Initiative





Utah's School Readiness Initiative is designed to improve the quality of preschool (BHQ Grant) programs and expand access in quality programs (ESA grant) for eligible students. The Initiative consists of three components and is governed by the School Readiness Team:

The School Readiness Initiative Grants

Becoming High-Quality (BHQ) Grant

This grant supports existing preschool programs to increase elements of high-quality programming. Grantees must serve at least 25% eligible students. The application for this grant is typically released at the beginning of the year. To be considered, applicants must demonstrate some elements of high quality. The grant is awarded per classroom. The expectation is for providers to increase the quality of their program and transition to the Expanded Student Access grant.

Expanded Student Access (ESA) Grant

This grant funds seats in existing high quality preschool programs for eligible students. Grantees must be meeting all elements of high quality listed in code and obtain an Early Childhood Environmental Rating Scale (ECERS-3) score of 3.67 overall and at least a 4 in language and a 4 in interactions. The purpose of the grant is to serve additional students in a high quality setting in preparation for kindergarten. The grant reimburses at a cost per child which is determined by the program's historical costs.

Results-Based Contract Grant

In 2014, Salt Lake County launched a Social Impact Bond (Pay for Success/Results Based Grant) that would provide high impact and targeted curriculum to preschool-aged children from low-income communities. These services were intended to increase school readiness and academic performance and thereby reduce the need for special education at a later age. Currently this grant is not open for applications or new solicitation.


