A. Policy Meeting

Representative Weight shared updates from the Policy Subcommittee and discussed its working approach in relation to the WIEC Purpose Statement, One Utah Roadmap, Utah Women & Leadership Project (UWLP), and current legislation.

- i. Representative Weight discussed the <u>UWLP Community Asset Map</u> and efforts to develop criteria for future meeting guests and topics for consideration.
- ii. Co-Chair Senator Escamilla recommended reviewing past WIEC strategic planning efforts and outcomes.
- iii. Dr. Madsen clarified the objectives of the UWLP and cited the <u>UWLP White Paper</u>
 <u>Series</u> as a means to inform legislators and advocates on specific issues impacting the women of Utah.
- iv. Representative Millner discussed the <u>New Unified Economic Opportunity</u>
 <u>Commission</u> and recommended connecting with this subgroup for information about its current efforts.





v. Co-Chair Commissioner Freigang recommended inviting former Commissioner and Lt. Governor Deidre Henderson and guest representatives from the Office of Child Care, Department of Workforce Services, and the Utah Division of Multicultural Affairs to future WIEC meetings.

 - ii. Kristen Schulz responded and clarified that one-time boosts may provide temporary benefits.
 - iii. Co-Chair Senator Escamilla described possible approaches and inquired about parameters for bonuses within the childcare industry.
 - iv. Kristen Schulz cited the Office of Child Care's criteria for licensed center-based practices.
- B. <u>Co-Chair Commissioner Freigang discussed the issue of childcare deserts and suggested getting feedback from guest representatives on this topic.</u>
- C. Commissioner Floyd shared industry insights as the former Director of the Office of Child Care and inquired about the benefits of providing to industry workers to combat low wages, high turnover, and low facility reimbursement rates.
- D. Kristen Schulz cited language from the American Rescue Plan Act of 2021 (ARPA).
