

List of Known CART Services for Utah

CART providers utilize court reporting equipment and a laptop to generate text of the spoken word allowing individuals with hearing loss to read what is being said in real-time (with a slight delay). Some local CART providers are willing to offer on-site services (physically present at the event) using a laptop with monitor or multimedia projector, while most CART providers offer remote CART services (physically located off-site) using internet-based technology such as skype and streamtext read on a phone, laptop or tablet. Availability of technology could accommodate large audiences for both on- and off-site services. Testing in advance is recommended to resolve any in-house technology problems. CART is an excellent option for individuals who are Deaf or Hard of Hearing who do not know American Sign Language, do not benefit from amplification, or have personal preference.
